Three day indoor art, craft and gift expo held in the Wisconsin Exposition Center, State Fair Park, Milwaukee, Wisconsin
This is the largest art, craft and gift expo in the Midwest held on the busiest shopping weekend of the year!

LOCATION: The expo is held in Halls "B" & "C" at Wisconsin Exposition. This section feature numerous exhibitor access doors as well as convenient trailer parking for exhibitors who need to restock during the event. The building is brightly lit so extra lighting is typically not necessary.

MEDIA: Pottery, ceramics, sculpture, paintings, graphics, photography, calligraphy, weaving, textiles, needlework, macrame, basketry, candles, jewelry, metalcraft, woodcarving, furniture, folkart, tole, leathercraft, stained and blown glass, floral designs.

ELIGIBILITY: Open to all artists and craftsmen, 18 or older who exhibit their own work. An invitation is directed to the individual craftsperson and is not transferable. Entry fee is returned if work is not accepted. Only art and craftwork that has been approved may be sold in your space. No agents or sales representatives allowed. The Selection and Review Committee reserves the right to limit categories and reject any work it deems unsuitable or non-compliant with its rules. Decision of the Selection and Review Committee is final.

PHOTOS: New exhibitors, or those changing their media, must submit three photographs of your completed work and two photos of you creating your work for evaluation and approval. All photos will be returned.


NOT ACCEPTED: Imported or commercially produced crafts, buy/sell items, candy or food products, live plants or wreaths, bulk potpourri, antiques, music CD's or video DVD's, contests or raffles, fundraising, kits, toy weapons of any type, any articles not made by the exhibitor.

DEADLINE: Entries will be accepted on a first-come basis until filled. Applications accepted by mail only.

FEE: \$350.00 for each 10' x 10' space. Registration and payment in full of entry fee is required for each exhibitor. Checks, money orders or credit cards are acceptable forms of payment (Visa, MasterCard). Make checks or money orders payable to Torbenson Shows, LLC, and mail with registration card to: Torbenson Shows, LLC, 2450 De Carlin Dr., Brookfield, WI 53045 Checks may not be postdated. There will be a \$25.00 fee charged for any checks returned for insufficient funds.

DEPOSIT - HOLIDAY Art, Craft & Gift Expo: For the 2010 Holiday Art Craft & Gift Expo exhibitors have the option of paying one-half (50%) of the total space fee with their application with the balance to be paid no later than November 1, 2010.

ACCEPTANCE: You will be notified by mail of acceptance or rejection of your application. Space assignment is at the sole discretion of the Selection and Review Committee. Specific locations or corners are not guaranteed. Space numbers are given out at expo setup only.
